Entry Fee: \$50. Registration will be from 3:00-4:00 PM. **Absolutely NO registration will be taken after the 4:00 PM deadline.** There will be an application included in this document for you to print and complete or a hard copy of the paperwork can be filled on the day of the pageant. Money order, exact amount in cash, or Venmo will be the only types of payment accepted. You are encouraged to fill out forms prior to coming to save time, but it's not required. **You must bring a hard copy of the birth certificate.**

Dress Attire: One piece swimsuit & long evening gown. Each contestant may have one female helper in the dressing room at a time. A name tag will be given which must be worn by the helper at all times. Someone will be checking helpers in and out at the door.

Each contestant will introduce themselves during swimsuit (name, number, parents & home town only) and answer an on-stage interview question during evening gown (judged according to confidence, grammar, content).

### Rules & Regulations:

1. A contestant must have reached the age of 16, but not 22, on October 31, 2024. **Each contestant must present a hard copy of their birth certificate with the entry form.**
2. A contestant must be a full-time/primary resident of Kentucky.
3. A contestant must be born female, single, never married, never had a marriage annulled, and never had any children.
4. Contestants must meet and abide by all rules and regulations of the Miss Kentucky County Fair pageant also.
5. No daughters of pageant chairpersons, executive fair board members or employees of the Pulaski County Fair Board are eligible to enter the pageant.
6. The Pulaski County Fair Board reserves the right to remove the winner of the pageant for behavior unbecoming Miss Pulaski County/Fair. This includes, but is not limited to, social media posts. All money, crown and sash must be returned.
7. Each contestant will introduce themselves during swimsuit (name, number, parents & home town only) and answer an on-stage interview question during evening gown (judged according to confidence, grammar, content).
8. The winner of Miss Pulaski Co. Fair will receive a cash award, crown, sash, trophy, flower bouquet, gift, and two nights' lodging at the state pageant in January of which she is expected to attend. She is also expected to escort the Little Miss & Mr. at their state pageant opening day of the state fair.
9. Four runners-up will also be awarded.
10. Previous winners may not enter again. Winners of the Miss Kentucky County Fair pageant are not eligible to enter.
11. No refunds given.
